## **ANNUAL MEETING:**

- 1) Called to order at 6:19 p.m.
- 2) Notice of meeting was mailed to all owners and posted a week prior.
- Quorum of Board all present, Florjan Gjekai. There was not a quorum of membership.
- 4) Waived reading of October 14, 2024 minutes.
- 5) Each Board member introduced themselves.
- 6) Unfinished Business:
  - a) Audit complete and will be posted on website.
  - b) Very little money left by old Board
  - c) Need to cut costs and raise revenue.
  - d) \$70,000 eliminated from Budget from salary that was paid to Todd.

- e) Saved \$100,000 on new insurance policy and added Flood insurance.
- f) Robert Kelly brought in \$50,000 from Spectrum giving them right to market their products.
- g) \$381,000 net result.
- h) Explained new Florida laws of Milestone and Reserve Study each by an engineer who will report on what needs to be repaired.
- i) Paid for 20 building permits for temporary shoring from work done 2 years ago.
- j) Signed contract for repairs of dangerous conditions to be fixed by end of year with all work to be approved by City of Clearwater.
- k) Milestone 1: visual inspection, Milestone 2: destructive testing if needed.

## 7) New Business:

- a) New insurance qualifies replacement cost.
- b) 20 units flooded during hurricane Milton and are under remediation to restore to livable condition. Stephen Gregson spoke explaining that our flood insurance policy is saving a lot of money.
- c) Raj Rajpal ended meeting stating that we should all work together to make Coachman Creek Condominiums a better place to live.
