1) Florjan explained due to the issue with a bore hole by building 25 would not fill the attorney advised that Helicon be contracted under an emergency to fill the hole asap. Florjan made a motion for same, Linda Pasquarella 2<sup>nd</sup> the motion he asked if any Board member had discussion, none did. Florjan called for a vote on the motion: Mary Rosen – Yes, Linda Pasquarella – Yes, Florjan Gjekaj – Yes. Motion passed and Secretary asked to record motion passed in minutes.

#### **OLD BUSINESS:**

#### **UPDATE ON WEBSITE & CONTRACTS POSTED**

1) Florjan explained that the altered minutes on the website were replaced with the correct minutes from our Secretary and that the contracts on the website need further attention.

2) Florjan encouraged unit owners to visit the website and give input of corrections or improvements needed to Ameri-Tech.

#### UPDATE ON ROOFING PROJECT

- 1) Florjan spoke about meeting with 2 fully vetted roofing contractors that the prior board president had met with and failed to come to contract with after 5 months. Florjan met with both contractors: Baker Roofing & #1 Home Roofing and both were willing to begin immediately.
- 2) Florjan asked for a motion for the award of the roofing contract, then asked for a 2<sup>nd</sup> and Linda Pasquarella, secretary, 2<sup>nd</sup> to award the roofing contract.
- 3) Florjan asked if there is any discussion: #1 Home Roofing offering a choice between a 12 or 18 month contract, 0% interest, \$0 down, all 28 roofs completed in 3-4 months.
- 4) Florjan propose motion to hire #1 Home Roofing, Linda 2<sup>nd</sup>, vote taken: Florjan Yes, Mary Yes, Linda Yes.
- 5) Madam Secretary please that the motion passed.

### UPDATE ON FLOOD DAMAGE REBUILD

- 1) Florjan gave update:
  - \*10 unit owners have express permission and are moving forward with their own contractor and several are already completed.
  - \*The contractor that is under contract with 8 of the unit owners completing start to finish within 6-7 weeks. Cornerstone explained it will take 6 months+.
  - \*During past week contractor Cornerstone Restorations and attorney Greenberg have resigned. Also, Ameri-Tech resigned from being project manager for Cornerstone. That leaves Strategic Claim as Public Adjuster and we will be in talks with them as soon as they get in touch.
  - \*Florjan made motion for final 10 remaining flood units & laundry room rebuild by Sharr Construction, LLC. Subject to Sharr Construction contracting with each unit owner individually and Coachman making the draw payments as they move forward to complete the rebuild. This contract is not to exceed \$290K or line item by unit estimate from FEMA Flood Claim. Mary Rosen 2<sup>nd</sup> motion.
  - \*Asked if any discussion and none.
  - \*Florjan called for a vote on the motion: Mary Rosen Yes, Linda Pasquarella Yes, Florjan Gjekaj Yes.

\*Florjan stated: Motion passed, secretary please record.
